THE AMERICAN SOCIETY OF PHARMACOGNOSY

ANNUAL MEETING IN ORLANDO WAS A HUGE SUCCESS

The 39th Annual Meeting of our Society kicked off on Sunday, July 19 at the very beautiful and spacious Coronado Springs Resort in Orlando, Florida. Being a Disney-owned resort, our meeting complex boasted of an impressive array of recreational activities for both children and adults. While the usual Disney characters were visible at every turn, the meeting was far from a Mickey Mouse – Donald Duck affair. For five great days, over 400 meeting registrants experienced cutting edge scientific presentations, natural products research discussions, and collegial interactions that surely sparked ideas that will undoubtedly lead to future discoveries. Friendly social gatherings allowed meeting participants to renew old acquaintances and to establish new relationships.

The symposia focused on strategies of accessing biological and chemical diversity, descriptions of emerging technologies that aid rapid isolation and characterization of new natural products, and methods that provide an adequate supply of natural products for clinical development.

A MESSAGE FROM THE PRESIDENT

Following in the tradition established by previous incoming ASP presidents, I welcome the opportunity to present a short message to the membership.

The American Society of Pharmacognosy continues to thrive in all respects, with the total membership now approaching 1,300. With about 40% of our membership coming from outside the United States, we are truly an international society with all the benefits and strengths which emanate from such global character. Our Journal of Natural Products reflects this character, with the 1997 volume containing papers submitted by co-authors from about sixty countries. We hear constantly about globalization of economies and the interdependent relationship of the world's nations; to me, the continuing expansion of our overseas membership is a very welcome trend which should be promoted to include more members from our "developing" country neighbors. With the majority of the world's natural resources concentrated in "developing" nations, and the more sophisticated technology currently residing mainly in "developed" nations, all those involved in the science of natural products stand to gain from closer collaboration and interchange between these two sectors. Our Society can play a leadership role in fostering such interaction, and indeed, a significant number of ASP members have had, and continue to have, productive collaborative research programs involving scientists from these nations. Candidates must be members of the Society who have made outstanding contributions to research on natural products. Awards and Grants for Students

To stimulate interest in all phases of natural products research, the American Society of Pharmacognosy is offering the following awards and grants:

1. ASP Student Research Award.

The ASP Student Research Award is designed to recognize outstanding research in the general area of natural products. The competition is open to all graduate and undergraduate students working for a member of the ASP. Students should submit a research paper describing his/her own work in the area of natural products. The applications will be reviewed by the ASP Awards and Funds Committee in a blinded competition. The research paper should conform in general to the format of the Journal of Natural Products, except that there should be no identification of the student, faculty, or school from

which the paper originated. The name and address of the contestant and his/her paper title should be provided in a separate letter accompanying the paper. Please include a self-addressed stamped postcard (no smaller than 3.25 by 5.5 inches) with the title of the proposal and name of the applicant. This postcard will serve as notification of receipt of the application. The award will consist of a \$500 cash gift and all expenses paid to present the paper at the annual meeting of the ASP (restricted to meetings held in the continental U.S.). The deadline for submission of the research paper is March 1, 1999.

2. Undergraduate Research Awards.

The ASP Undergraduate Research Awards consist of a stipend of \$2,000 to the student and \$500 to the advisor to help defray the costs of the research. There are no limitations on the type of research to be conducted other than that it should be in the area of natural products. Persons interested in submitting an application for consideration should send the following before March 1, 1999:

a. An outline of the research to be conducted, written by the student submitting the

application. This should include a statement of the problem and the goal(s) of the research, and a brief discussion of the methodology. This outline, with pertinent references, should not be longer than four double-spaced, typed pages.

- b. A transcript of all college work attempted.
- c. A curriculum vitae.
- d.A letter of agreement by the faculty advisor (a member of the American Society of Pharmacognosy) for the project, indicating a willingness to supervise the project, and provide the facilities and equipment for the conduct of the project. The letter should also include a statement about the student's academic performance and suitability to perform the work proposed.
- e. A self-addressed stamped postcard (no smaller than 3.25 by 5.5 inches) with the title of the proposal and name of the applicant. This postcard will serve as notification of receipt of the application.

Although not an absolute condition of the awards, students selected are highly encouraged to submit results of their research for presentation at an

annual meeting of the ASP.3. Lloyd Library and Museum Grants.

This grant program was established in cooperation with the Lloyd Library and Museum. In keeping with the Lloyd Library's interest in promoting student activities, two \$500 travel awards to attend the national ASP meeting will be awarded. These awards will be made based on excellence in both scholastic and research activities in the field of natural products. Application can be made by submission of a short (1-3 pages) synopsis of the work to be presented, a curriculum vitae, a current transcript and a letter of recommendation from the advisor. Applications are due March 1, 1999.

4. Travel Grants for Graduate Students.

Graduate students under the supervision of a Society member are also eligible for a travel grant of \$300 to \$500 to enable them to attend a Society meeting and present a paper. Application can be made by submission of a short (1-3 pages) synopsis of the work to be presented, a curriculum vitae and a letter of justification/recommendation from the advisor. All awards are contingent on the acceptance of the paper for presentation

by the Scientific Program Committee. Applications are due March 1, 1999. Awards and Grants for Activ

1. Research Starter Grants. ASP small research grants from \$2000 to \$5000 are available for active members in the first eight years after earning their Ph.D. and in the first five years of their first independent career position. These are one-time awards and are not subject to indirect costs. Application can be made by

submission of a research proposal of no more than four double-spaced, typed pages. A budget should accompany the proposal and the investigator should also provide a statement of his current funding. A curriculum vitae of the investigator must be included with the proposal and budget. The deadline for submission of application for these grants is March 1, 1999. Please include a self-addressed stamped postcard (no smaller than 3.25 by 5.5 inches) with the title of the proposal and the name of the applicant. This postcard will serve as notification of receipt of the application.

2. Travel Grants for Active Members.

Beginning with the 1994-1995 awards cycle, selection and presentation responsibility of this prize was transferred from the APhA Academy of Pharmaceutical Research and Science Awards Committee to the American Society of Pharmacognosy Awards Committee.

Criteria: Both undergraduate and graduate students in

schools or colleges of pharmacy are eligible for this award. The student does not have to be a member of the American Pharmaceutical Association or the APhA Academy of Students of Pharmacy or the American Society of Pharmacognosy to qualify. Student applicants should submit a full research paper (introduction, experimental, results, discussion and references, with figures and tables as appropriate) and a letter certifying status from the university registrar or graduate dean. The deadline for submission of applications is March 1, 1999. Nature of Award: The Kilmer Prize consists of a gold key, suitably inscribed, bearing the likeness of Dr. Kilmer. The APhA makes

available a complimentary registration and up to \$300 to enable the winner to attend the meeting at which the award will be given. The American Society of Pharmacognosy also provides an honorarium of \$300 for the named recipient.

guidelines for members embarking on such collaborative programs (*J. Nat. Prod.*,1997, 60, 654-655), and the symposium on the International Cooperative Biodiversity Groups, held at the recent ASP meeting in Orlando, illustrated the achievements of several such programs.

Continuing on the international theme, most of us are aware of the upcoming joint meeting of the ASP and our European counterpart societies, to be held in Amsterdam from July 26-30, 1999. The theme of this meeting is "2000 Years of

Natural Products Research -Past, Present and Future", and it promises to be an exciting and stimulating event. Details are available on the ASP Website (www.phcog.org) and in the Newsletter, and I encourage you to attend. Then, in late July, 2001, our colleagues from Mexico will be hosting the 42nd ASP Annual Meeting in Oaxaca, a beautiful city which is a center of pre-Columbian and colonial history and culture, located a 30 minute flight from Mexico City. The anticipated attendance of many delegates from Central

and South American countries will add to the value and interest of this meeting. Plans for the 41st Annual Meeting, to be held in Seattle from July 22-26, 2000, are already well under way. The venue of Seattle will also make this meeting a major attraction for international participation, particulary from the Pacific Rim countries. All in all, the next three years' meetings promise to be great scientific and cultural events!

Last year, our President, Bob Borris, in his message to the Society, mentioned natural products coming to "a fork in the road", with the escalating use in the U.S. of natural substances in the form of alternative or herbal medicines, nutraceuticals and food supplements. He referred to the need for graduates of pharmacognosy and chemistry programs to have a sound grounding in quantitative chemical analysis to handle the standardization of herbal extracts. The emergence of this area of natural products as an important player in the U.S. health care arena, while boosting the image of natural products in the eyes of many members of the U.S. public, poses challenges to all of us determined to ensure that the high standards of natural products science are maintained in the development and promotion of these products. While standards for their production and use have been in force in Europe and some Asian countries for

some time, such regulatory control is still lacking in the U.S. An Ad Hoc Organizing Committee, under the leadership of Alice Clark, is planning an ASP Interim Meeting on **Botanical Dietary Supplements** in Tunica, Mississippi, in the Spring of 1999. Symposia focusing on the science being applied, and still required, in this area will be held. These symposia will serve as a forum for ASP members and other members of the natural products community to provide leadership in the recommendation of sound scientific guidelines for the development of safe and effective products. Keep in contact with the Website and Newsletter for further details.

At the ASP meeting in Orlando, there were several presentations from colleagues in the industrial sector on promising developments in natural product drug discovery, I was impressed by the enthusiasm and unequivocal support expressed by the speakers for the continued, important role of natural products in the drug discovery process. Nature remains the ultimate source of unique combinatorial libraries, but it is clear that innovative approaches to source selection, screening, compound purification and dereplication, and structural modification are essential in order to remain competitive with other methods of molecular diversity generation - and

also to remain competitive in the arena of research funding! While Institutional natural products programs cannot be expected to compete with industry in all these areas, they can continue to play a vital role in the basic research, and the scope for the formation of productive, multi-disciplinary collaborations with groups having expertise in the other essential components of the discovery and development process needs to be explored in order to optimize the chances for success. One thing is certain, future success is very much dependent on a willingness to adapt to the changing paradigms and circumstances.

I really feel privileged and honored to serve as President of such a fine Society. The Society owes its present dynamic and excellent condition to the strong commitment and dedicated service of many members over the past nearly 40 years. I want to thank those who have served, and continue to serve, ASP in various capacities, and all of you who support the Society through your membership and attendance of meetings. We can look forward to a stimulating and challenging year as we approach the new millennium!
