Abstract: The American Society of Pharmacognosy Foundation Papers consist of letters, printed emails, meeting minutes and reports, and financial documents of the American Society of Pharmacognosy (ASP) and the American Society of Pharmacognosy Foundation. The organization is referred to interchangeably throughout this document and papers within this collection as the 'ASPF' or 'Foundation'.

Arrangement: The collection consists of 19 boxes.

Provenance: The founding ASPF treasurer Dr. Robert "Bob" J. Krueger donated this collection of papers and materials to the Lloyd Library in 2016. They were previously arranged in four bankers' boxes and divided by years.

Access Restrictions: Access to certain series is restricted to the public due to personal identifiable information and account information present in the papers.

Conditions Governing Use: The Lloyd Library & Museum retains copyright to the bulk of the collection. It is the responsibility of the researcher to obtain copyright permissions of all interested parties. Request for Reproduction Rights from The Lloyd Library & Museum form.

Conditions Governing Reproduction and Use: Researchers may photograph materials using personal cameras or other electronic devices, only for purposes of private study, scholarship, research, or classroom use.

Biographical History: The American Society of Pharmacognosy Foundation (referred to as 'ASPF' or 'Foundation') was founded on July 19, 1990, at the ASP Business Meeting held at the International Meeting in Bonn, Germany. The initial ASPF Board included the following members and their roles: Matt Suffness (Chair), A.D. Kinghorn (Vice-Chair), Robert J. Krueger (Treasurer), William J. Keller (Secretary), David Slatkin (Board Member) and Alice Clark (Board Member). The mission of the Foundation is to promote, support, and further the scientific and educational interests and purposes of the American Society of Pharmacognosy. The ASPF champions the research, education, training, and publication of natural products and pharmacognosy across the world. They provide annual research awards to ASP members and provide travel grants and additional financial support for the ASP's annual conference. The ASPF also supports undergraduates, graduate students, and graduates who just entered their professional careers. It continues to operate today under 501(c)(3) and 509(a)(3) statuses.

Robert "Bob" J. Krueger, PhD (1948-2023) was a Professor of Pharmacy at Ferris State University from 1975 to 2011. He graduated from the University of Connecticut in 1971 with a bachelor's in pharmacy, and later earned a doctorate in pharmacognosy from the University of Iowa. Dr. Krueger was a member of the ASP starting in the 1970s. He was a member of the Constitution and By-Laws Committee (1979, 1983-84), Chair of the Continuing Education Committee (1985), and member of the Resolutions Committee (1991-1995). He was nominated and approved to be Assistant Treasurer of the ASP in 1989. The following year, he became the Treasurer of the ASPF and served that role until 2021. Additionally, he was inducted as an Honorary Member of the ASP. Dr. Krueger died in Grand Rapids, Michigan on January 1, 2023.

Scope and Content: This collection consists of letters, printed emails, meeting minutes and reports, financial documents and statements, and donor information.
